FACT SHEET

WHAT IS THE FCARC?

It is an organization of parents and friends joined together to further the interests of retarded children by attempting to provide better facilities for their care, training, education and welfare. It is a non-profit group, affiliated with the Virginia Association for Retarded Children and is one of 500 units of the National Association for Retarded Children.

WHAT IS MENTAL RETARDATION?

It is a condition of impaired or incomplete mental development. There are many degrees of mental retardation.

OBJECTIVES OF THE FCARC

- To promote the general welfare of mentally retarded children of all ages.
- To further the training and education of personnel for work in the field of mental retardation.
- To further the enactment and implementation of legislation in behalf of the mentally retarded.
- To acquaint the public with the needs of the mentally retarded.
- To contribute to programs dedicated to research on the problem of the mentally retarded.
- To solicit and receive funds for the accomplishment of the above purposes.

THE SIZE OF THE PROBLEM

Three children out of every 100 born are destined to be mentally retarded. EVERY parent is vulnerable, regardless of economic status, race, color or religion. Intellectually, retardates range from the totally helpless to the many more who are very little differ-

ent from the "normal." A comparison of permanent afflictions, based on each 100,000 population follows:

THE PROBLEM IN VIRGINIA AND FAIRFAX COUNTY

- 1. Lynchburg Training School and Hospital, our state-supported institution for the mentally retarded of all ages, has 2,600 patients in space planned for 1,900. Several hundred more are on the waiting list. Parents pay the State \$65 per month per child for care at Lynchburg. It is estimated that there are over 15,000 individuals between the ages of six and thirty who are mentally retarded in the State of Virginia who are not in institutions.
- Exact figures are not available on the number of retarded in Fairfax County. However, based on the national average (3%) and the number of children in the Fairfax County School system (43,000— 1957 pop.) it is estimated that the number exceeds 1,000 retardates of school age.

WHAT DOES FAIRFAX COUNTY PROVIDE?

Fortunately, Fairfax County has recognized the problem and during the past few years, through the efforts of the County Officials and the FCARC, additional classes have been added until in 1957-58 a total of 19 classes are available. These 19 classes serve approximately 250 children. One additional class has been added during the 1957-58 school year. Training is available until about 16 years of age. Children, who for one reason or another, do not fit into the public school classes must be cared for at home, placed in an institution, or sent to private schools at a cost of \$65 to \$400 per month to the parents.

WHERE DO FUNDS GO?

15% goes to the Virginia Association for Retarded Children; 15% goes to the National Association for Retarded Children; 70% is retained by the local association to meet its objectives.

FCARC PROGRAMS

- Continuance and expansion of the summer recreation program.
- 2. Establishment of special nursery classes for children under six.
- Working toward increasing the number of special education classes.
- 4. The initiation of vocational training and sheltered workshops.
- Provision for scholarships—to encourage more teachers to enter the field of special education.
- The support of social training, such as Boy Scouts, Cub Scouts, Girl Scouts, Brownies, Campfire Girls, etc.

WHY WE ARE NOT A MEMBER OF UGF

We need to tell the public directly about the problems of retardation in order to try to make everyone realize that these children have a right to be happy and enjoy the same privileges as the normal child, so that they, too, may develop their full potentialities. It is necessary to have a full scale program with specific budget requirements already in existence, to qualify for UGF. This program is still in the planning stage.
