FEDERATION TAKES STAND ON COUNTY BUDGET

Each April the Fairfax County Federation of Citizen's Associations takes a stand on the proposed County Budget. This year was no exception.

The school budget claimed major attention of Federation members tho are dedicated to a vigorous program of school improvement. The Federation supported the proposed decrease in elementary school pupil-teacher ratio, the capital outlay proposals for school construction, and the proposed increase in teachers salaries (including the controversial longevity steps provision). The last point was passed only after a heated debate. The longevity provision was passed because, in principle, the Federation cannot afford to place itself in ocposition to measures which benefit the school system of the County.

The nembers of the Federation have long ago faced up to the fact that, if we want improvements in county services, we have to be willing to pay for them. Therefore, the Federation supported the proposed plans for construction of a library and police headquarters buildings in the county. By the same reasoning, the Federation strongly urged that the County buy land now for future park needs.

The group also came out for a sound and a more conservative fiscal policy. It recommended that short-lived expenses should be strictly on a pay-as-you-go basis and that the County should borrow money only for long-range capital items.

## NANTED - HELP CN PUBLIC RELATICNS PROGRAM

As announced in last month's Newsletter, plans are being made for expansion and improvement of the Association's public relation's activities. As part of this proposal, it is hoped that next year's public relations staff can be enlarged to provide for joint chairmanship--one chaiman to handle external publicity concerning the community and its activities (through press releases to newspapers, radio, TV, etc.) and one chairman to handle the Newsletter.

Both chairmen would be assisted by a single staff consisting of about eight editors who would serve as collection points for news on broad areas of community activity and interest. Each editor, therefore, would establish contacts with and receive news items from the various community organizations and activities within his scope of responsibility and channel the items to the chairmen for release at appropriate intervals. The use of editors, rather than reporters is suggested to minimize demands on these people other than for editorial review and some re-write work.

In this way it is hoped that the Association's public relations organization can be of positive assistance to the entire community, rather than restricted to Association activity alone.

In addition to consideration of the county budget, the Federation appealed to the County Board of Supervisors to find some regulatory ordinances to protect residents of the county from consequences resulting from construction and operation of utility lines and services.

In taking these stands, the Federation was performing one of its major civic services. It provided a democratic sounding board where the wishes of the people could be heard. Several members of the County Board of Supervisors were on hand to hear them.

The next meeting of the Federation will be on Nay 16 th at the Annandale Elementary School. Visitors are alvays welcome.

FUBLIC RELATICNS (Cont'd)
Present staffing needs are for the following: (I) Co-Chairman on publicity, (2) Secretary, (3) School and PTA Editor, (4) Church Editor, (5) Men's and Sports Editor, (6) Nomen's and Social Editor, (7) Pimmit Hills Citizens Assoc. Editor, and (8) Advertising Editor.

Indications are that, through inclusion of a reascnable amount of paid advertising, the Newsletter can be selfsustaining. Experience of other citizens associations confirm this. At present, hovever, the Newsletter represents a cost of about $\$ 20$ a month which must be paid for completely out of the Association's meagre revenues.

Accordingly, the need for an Advertising Editor is paramount. Recognizing that this job could be a back-breaking one if carried out on a personal contact basis, it is proposed that ads be solicited through a large-scale stancardized mail order campaign with a minimum of face-to-face contacts.
