ASSOCIATION MEETING - The sixth general meeting in the current session of the Pimmit Hills Citizens Association will be held at 8:00 P.M. TUESDAY, FEBRUARY 3 in the PIMMIT HILLS SCHOOL.

Principle items on the agenda of the Association's February meeting include: (1) a motion picture presentation of the running of the 1959 five hundred mile Indianapolis Speedway race made available by Mr. Ficke, operator of the Hobile Gas station in Pimmit Hills Shopping Center; (2) a progress report concerning the "Curbs and Gutters" project discussed in last month's meeting and Newsletter; and (3) action on two proposed resolutions relating to school integration. TWO PROPOSED RESOLUTIONS ON SCHOOL INTEGRATION TO BE CONSIDERED AT

PIMMIT HILLS CITIZENS ASSOCIATION'S FEBRUARY 3 MEETING

We personally dislike having to devote space to this subject in the Newsletter, and we find it even more distasteful to see ourselves and our neighbors and friends embroiled in it in the Association's general and executive meetings.

The Executive Committee, particularly President Doug Glass, have put much time and energy into trying to help unify the community and many of its organized groups to focus attention and concentrate efforts on projects of a purely local and mutually beneficial nature. The community recreation center and the street and drainage improvement ("curbs and gutters") projects are two of many possible examples.

These are facilities we believe are badly needed. They require every ounce of attention toward their realization we can possibly give them. And, above all, they represent the type of objectives with which local organizations can cope with greatest effectiveness and satisfaction.

At best, our effectiveness in dealing with issues such as school integration is questionable. Heanwhile, much time and effort otherwise available for more satisfying pursuits is consumed, and the emotionalism and bad feeling created serves only as divisive force in the community, undoing much hard-won progress toward developing a unity of purpose and endeavor.

The integration issue is nevertheless before us, and we have been called on by the Fairfax County Federation of Citizens Associations (of which this Association is a member) to vote on the Federation's proposal as to how it shall be dealt with in our county schools. Our responsibility is clear and inescapable. We only hope we can fulfill this responsibility with the least amount of antagonism and disruption of our many other worthwhile pursuits.

On pages 2 and 3 are two proposed resolutions on this subject which will be presented to Association members at their Feb. 3

The Executive Committee of the Fairfax County Federation of Citizens Associations has approved in principle the following resolution of its School Committee to be presented for consideration by member associations at its regular March meeting or, if necessary, at a special meeting to be held sometime in February.

PROPOSED RESOLUTION "A"

"In view of the fact that County schools may be closed during the coming year and in view of the seriousness of the educational and economic consequences of such an event, the Fairfax County Federation of Citizens associations adopts the following policy statement:

- "1. The Federation urges all eligible citizens in Fairfax County to register immediately in order to be able to participate in any public referendum on the school issue;
- "2. If a special session of the General Assembly is called, the Federation urges opposition to the adoption of any Constitutional Amendment which would weaken the General Assembly's obligation to operate and maintain public schools throughout the state;
- "3. If any such Amendment is adopted, the Federation urges that cities and counties, be permitted to operate their own public schools;
- "4. Since, under the rulings of the United States Supreme Court, there appears to be no way of maintaining segregated public schools indefinitely, and since it is far better to have a planned program of gradual desegregation in operation over a period of years than to have spot desegregation determined by fortunes of court decision, the Federation urges the Fairfax County School Board to demonstrate to the Federal authorities its good faith in com-

plying with the Federal law by taking positive action towards developing and adopting a desegregation plan before any court action is brought against the School Board. The plan should provide for:

- "A. Desegregation to begin at a set date in the First Grade and to proceed upward at the rate of one grade a year;
- "B. Initiation of a training program for teachers and administrative personnel to help them deal with the problems of desegregation;
- "C. Adjustment of any existing differences in the standards of various public schools of the County system;
- "5. The School Board should seek an injunction against the enforcement of massive resistance laws which would close the County schools if any of these schools should be desegregated; and
- "6. If court action is instituted against the School Board, the School Board should take steps to have the Governor of Virginia, and any other state officials responsible, made party to the litigation."

The following resolution is now before the Pimmit Hills Citizens Association, having been tabled at the Association's October meeting. The Executive Committee feels that both resolutions now deserve equal consideration.

PROPOSED RESOLUTION "B"

"Whereas, Integration of the public schools will encourage Negro families to settle in our peaceful community, as is evidenced by the history of similar formerly desirable residential communities in Washington, D. C.; and

"Mhereas, It is our personal preference to reside among, and raise our families among, and educate our children among people of our own race; and

"Whereas, Upon the entrance of a Negro family a large number of our neighbors would abandon their homes for whatever price they could get for them; and

INTEGRATION (Cont'd)

"Whereas, With the mass exodus which would necessarily result, the remaining residents would suffer a loss of value of their homes because of the immediate availability of the large number of deserted, unsold houses; and

"Whereas, The majority of us have our life savings invested in our homes and the loss of these hard-earned assets would irreparably retard our personal economic progress to the extent that our families would be deprived of many necessities which at present we can expect to be able to provide for them; and

"Whereas, The protection of our collective interests in this matter of preserving our homes and our community transcends all partisan, sectarian, and political lines; therefore, be it

"Resolved, That the Pimmit Hills Citizens Association does herewith proclaim unqualified support for the laws which have been duly enacted in our General Assembly by the representatives of the overwhelming majority of the citizens of our commonwealth in order to protect our children, our homes, and our communities from the destructive results of forced integration of the races in our community schools."

LEMON ROAD SCHOOL by Shirley Barnes

In its January 12 meeting, the Lemon Road PTA voted to recommend that the county approve a guarantee a complete year's salary for teachers in the event schools are closed.

ASSOCIATION GIVES \$200 TO FAIRFAX COUNTY HOSPITAL FUND

Members of the Pimmit Hills Citizens Association, at the group's January meeting voted to give \$200 to the Fairfax County Hospital Founders' Fund. Donations to the fund will be used to equip the hospital. Funds for construction and operation were made available by the County and the Federal governments, but money for equipment was not otherwise provided for.

According to Mr. D. L. Vilkins, Chairman of the Fairfax County Hospital and Health Center Commission, the hospital will be in operation in November, 1960.

PROGRESS ON CURBS AND GUTTERS PROJECT

Ballot-type questionnaires were sent out with last month's Newsletter to find out from residents of Pimmit Hills Sections 1 -5 whether they would prefer a monthly tax increase of \$2 to \$3 to finance street and drainage improvements in their areas or would prefer indefinite continuation of the present conditions. The forms were to be returned to Association President Glass by Jamuary 20 so the Association could present a fair sample of resident opinion to the County for possible action by the end of the month. At this writing the number of returns was far too few but overwhelmingly in support of the proposal. More up-todate news of the project will be available at the Association's February 3 meeting.

Space limitations prevent us from printing a transcript of Mr. Whytock's excellent talk on the history of the Curbs and Gutters project and the lively discussion which followed in last month's meeting. We hope to have copies of the material available as soon as they can be reproduced.

COUNTY CONSIDERING PURCHASE OF PIMMET SERVICE WATER AND SEVACE SYSTEMS

According to reports received by Association President Doug Glass at last month's meeting and from the publication "Fairfax Newsletter," county officials were to meet during January with the county Tater Authority to discuss the possibility of joint action to acquire the Pimmet Service Corporation's sewer and water systems.

County Executive Carlton Massey is said to have told the Board of Supervisors that George Offutt, owner of Pimmet Service is not interested in disposing of the sewer system separately but might sell if offered a deal on both systems. The county's thought is that the Mater Authority might be able to acquire the water system; in which case the owner might be willing to make a lease-purchase agreement on the sewer system.

Total value of the sever system, including the treatment plant, and the cost of extending a connection to the CIA trunk sewer, is put at \$696,865. The county's plan would be to halt operation of the plant, and pump the sewage to D. C. for treatment.

The County Executive recommends that nothing be done definitely to acquire the system until there is complete agreement with the D. C. Government on treatment of Fairfax County effluent in the Blue Plains plant. He reported that agreement was near on the administrative level but that no formal contract has yet been made.

These actions follow on the heels of the (in our opinion) heroic and successful efforts of Association Public Utilities Committee Head, Julius Meier and President Glass last Fall in presenting the Association's case against both the operation of the sewer plant and a petition to the County Board to permit additional tap-ins on the system.
