PRESIDENT:

CHARLES R. LEMIS, 400 Leonard Road. Mr. Lewis, originally from Ilion, N. Y., has been a resident of Fimmit Hills since February, 1952. He holds an AB degree in geology from Hamilton College, and is presently a geologist with the U. S. Geological Survey, Department of Interior. He has taken an active interest in the citizens' association since 1952, was a district representative for several years, was chairman of the membership committee last year, and in 1955 served briefly as president of the association before being sent out of the country on a field assignment.

SENIOR VICE PRESIDENT:

TREASURER:
