JUNE 1952_ NEWSLETTER

SECTION I

The purpose of this Newsletter is to inform all members of the Association of what projects are being undertaken and what progress is being made on those projects already underway. In addition to this type of information, it is planned to include those items of common interest which are worthy of publication.

Your District Representative will gladly accept any suggestions or contributions which you may offer to increase the value of this Newsletter.

It is planned to publish a Newsletter each month. The date of publication will be within the week following the regular monthly meeting.

SECTION II

The information contained herein is made up from excerpts of the official minutes of the regular meeting held on Tuesday evening, June 3rd, 1952, at the Dunn Loring School House.

a. Proposal to Amend By Laws

The Chairman of the District Representatives Committee submitted a written recommendation to amend Section 6 (a) of the By Laws. Briefly, this amendment will remove from the By Laws the requirement that the Chairmen of the Standing Committees be selected from the Membership of the District Representatives Committee. This recommendation for amendment will be discussed and voted upon at the next regular meeting.

b. Curbs and Gutter Installation Project

The District Representatives turned over to the Chairman of the Curbs and Gutters Committee on May 28th, 1952 the completed questionnaires. Although only 71% of the home owners replied to the questionnaire, there was a majority of votes for this service in the affirmative. The breakdown on a percentage basis of the 71% of homes polled reads as follows:

1.	Desire: curbs and Gutters	71%
2.	Do not desire curbs and gutters	7%
3.	No preference	7%
4.	Will agree if a majority desires curbs and gutters	5%
	Desire curbs and gutters under various conditions	10%

A "lively" and "extended" discussion on this subject was held immediately following the Committee report. By a voice vote of the assembled membership, it was decided to instruct the Committee Chairman to continue investigations of ways and means to provide curbs and jutters. It was also decided to combine the activities of the present Roads Committee and the Curbs and Gutters Committee to develop these inseparable projects concurrently.

As a product of this discussion, a motion was made, seconded and approved by voice vote to have this organization submit a letter to the House of Representatives Committee investigating shoddy construction of homes constructed under Veteran's Administration's Certification. It is intended that the poor drainage conditions in Pimmit Hills be cited in the letter in question. The subject of Curbs and Gutters promises to be a lively one, with all of us deeply concerned. The attendance of all members at regular meetings is urged so that a wide coverage of public opinion can be obtained. If you have not yet completed your questionnaire on this subject, do so now, and send it to your District Representative.

c. Street Lights

Our survey on street lights was also completed. The survey indicates that 82% of the home owners expressed a preference. Percentage figures as follows indicate the return:

1. Desire street lights.

65%

2. Will agree if a majority desire street lights

16%

A motion to table action until later in the year was made. This motion was defeated by a voice vote, and the committee instructed to conduct further research, reporting to the organization at the next meeting those courses of action available.

d. Real Estate Taxes

Col. Lawford presented a report concerning his investigation on real estate taxes. He reported that there are two investment companies that have granted mortgage loans in the Pimmit Hills Area - Investors Diversified Services and The Colonial Mortgage Loan Company. Both companies pay the real estate taxes at the end of each year. The cost of the taxes is amortized and included in the monthly payments for each home.

At the end of each year, the Tax Collector of the County sends a tax statement for each home owner to the appropriate mortgage loan company. If any home owner should receive a tax statement by mistake, it should be sent to the appropriate mortgage loan company.

Should there by an overpayment when the tax statement is received, Investors Diversified Services will refund the difference each year. Colonial Mortgage Company will refund the difference very two years, and retain 10% of the difference in a reserve account.

The average taxes paid on a property in Pimmitt Hills for the year 1951 was between \$90.00 and \$95.00. The amount collected each month by Investors Diversified Services is \$10.54. The amount collected by Colonial Mortgage is \$9.00. No refund can be expected until the year 1953.

e. Street Signs

The street signs to be installed will be delivered on or about 1 July 1952. The erection of posts should commence in the near future. A sample sign was displayed at the meeting.

f. Safety Signs

Several signs cautioning against speeding due to children playing have been erected. Suggestions concerning locations for additional signs are requested.
