ASSCCIATION LEETING - The second general meeting in the current session of the Pimmit Hills Citizens Association will be held at 8:00 P.M. TUESDAY, CCTOBER 7 in the PIMMIT HILLS SCHOOL.

Principal items on the agenda of the Association's October meeting include: (1) a talk on roads by a Virginia highway engineer (see below), (2) discussion of a draft revision of the Association's Constitution, a copy of which is attached to this Newsletter, (3) special election for Association Treasurer (item below), and (4) discussion of certain questions concerning integration and segregation for the purpose of instructing the Association's delegates to the Fairfax County Federation of Citizens Associations on matters which may be taken up by the Federation.

#### HIGH AY DEPT ENGINEER MAY SPEAK HERE ABOUT CHANTILLY ROUTE

The Pimmit Hills Citizens association's program committee is pleased to announce that it has tentatively scheduled as speaker for our October 7 meeting, Hr. F. L. Burroughs, Resident Engineer, Virginia Department of Highways.

This presentation is extremely timely, since one of his topics is the proposed access routes from Chantilly to their connecting links. According to one proposal, which has received a good deal of attention by the Civil Aeronautics Administration, one of these links consisting of a 400 foot right-of-way may cross part of Pimmit Hills.

Mr. Burroughs would also speak on the general road situation in the area.

#### ASSOCIATION TREASURER STILL NEEDED

The reception held for the parents and teachers at the school on September 15 proved very successfull and the long reception line was avoided by teachers meeting parents of their respective classes in the classroom. This was followed by a general gathering in the school cafeteria, where refreshments were served by Betty Carr and members of her Hospitality Committee.

The band program for this year is off to a very good start. Over forty students have signed to participate so far, and it's expected that others will join during the remainder of this month.

The library allocation this year has been announced. The school's share of the fund is 1,096. This will provide many new books for our children to read and will improve our library considerably.

The school expansion program this year has increased the number of classes from 16 to 22 and brought an additional 20% increase in the student body. With the larger number of students, PTA membership this school year should also show an increase.

# PROPOSED PIMMIT HILLS CITIZENS! ASSOCIATION CONSTITUTION

#### ARTICLE I NAME

The name of this Association shall be "The Pimmit Hills Citizens' Association".

#### ARTICLE II PURPOSE

- a. The purpose of this Association is to promote and advance community welfare; to strive to perpetuate this community as a residential center; to give special attention to the promotion of public improvements such as safety, educational, recreational, social, and cultural programs; and to cooperate with organizations of a similar purpose.
- b. In its activities the Association shall be strictly non-partisan, non-sectarian, and non-political. Further, no collective stand in the name of this Association shall be taken on any issue on which a state or county referendum is scheduled, except that the results of a poll of the membership on any question may be announced as the collective position of this Association. A poll of the membership shall be conducted as specified in the By-Lays.

#### ARTICLE III MEMBERSHIP

- a. All residents in and non resident property owners of Pimmit Hills and areas adjacent thereto, 18 years of age or more, shall be elegible for membership in this Association.
- b. Only members in good standing as defined in the By-Laws shall exercise the rights of membership.

#### ARTICLE IV OFFICERS

- a. The officers of this Association shall be a President, Vice President, one Regional Vice President for each of the several regions defined in the By-Laws, Secretary, and Treasurer. The duties of the officers shall be such as usually pertain to their respective offices and as herein defined.
- b. The President shall preside at all meetings of the membership and officers. He shall appoint all committees and appointive officers not otherwise provided for herein and shall be an ex-officio member of all committees except the nominating committee. He shall cast no open vote at any meeting of the membership except to break a tie vote.
- c. The Vice President shall preside at all meetings and functions of the Association in the absence of the President. In case of resignation, death, or other disability of the President, the Vice President automatically shall become President for the unexpired term. The Vice President shall be a delegate of the Association to all federations, organizations, or conferences of civic groups to which the Association belongs or decides to send representatives. Should more than one delegate to any such group be required the Vice President shall be chairman of the delegation.
- d. The Secretary shall keep a roll of the officers, committee members, appointive officers and members in good standing of the Association; shall keep the

minutes of the meetings, issue publications of the Association and official notices, and gather and preserve all written records of the Association.

- e. The Treasurer shall collect and receive all monies for the Association and maintain the funds and records pertaining thereto in strict accordance with the procedures prescribed in the By-Laws. He shall make no disbursements from the Association's funds except for purposes approved by the membership and in accordance with the Constitution and By-Laws.
- f. The Regional Vice Presidents shall serve as members of the Executive Committee. Their function shall be to coordinate the activities of the Association so as best to serve the interests of all of the Regions.
- g. The Elective officers of the Association shall act as an Executive Committee. Their duty shall be to conduct the business of the Association not otherwise provided for in the Constitution and By-Laws.
- h. Standing and Special Committees shall be established as defined in the By-

#### ARTICLE V ELECTIONS

- a. All officers of this Association shall be elected at the Annual Meeting for a term of one year. They shall be elected by secret written ballot by a majority vote of the members in good standing present and voting, provided that in case no candidate has a majority, a second vote shall be held between the two candidates having the most votes on the first ballot.
- b. A nominating committee of a least three persons shall be elected by the Executive Committee. The composition of said Nominating Committee shall be announced at the meeting which is two regular meetings prior to the election of any officer or officers. Immediately prior to said meeting the names of the members of the Nominating Committee shall be officially published as prescribed in the By-Laws.
- c. The Nominating Committee shall select one or more elegible candidates for each office to be filled. The selections of the Nominating Committee shall be announced at the meeting which is one regular meeting prior to the election of any officer or officers. Immediately prior to said meeting the names of the selections of the Nominating Committee shall be officially published as prescribed in the By-Laws. Following the report of the Nominating Committee, nominations from the floor shall be in order.
- d. Unless otherwise herein provided, a special election shall be held to fill any office which becomes vacant. Such election shall be held at the third regular meeting following the announcement of the vacancy in the manner prescribed for the elections at the Annual Meeting. The Executive Committee shall make an interim appointment to fill any vacancy until the special election is held.
- e. Each Regional Vice President shall be a resident of the region which he represents. They shall be elected only by members residing in the respective regions. At least five votes shall be required to be cast for election as Regional Vice President. In the event that either five votes are not cast or there is no nominee for said office, the Executive Committee shall appoint a resident of that region to fill the office.

f. Officers may be removed for cause upon a two-thirds vote, provided the motion was introduced and seconded at a previous meeting and the officer concerned has had an opportunity to answer the charges in person.

#### ARTICLE VI MEETINGS

- a. Regular meetings shall be held monthly except during the months of July and August at a time and place specified in the By-Laws.
- b. The President may call a special meeting at any time, and shall do so upon the written request of a majority of the Executive Committee or of a quorum of the membership. The Secretary shall send notice of the time, place, and purpose of the special meeting to each member, which notice shall reasonably be expected to be received at least 24 hours in advance of the special meeting. No business shall be transacted at such special meeting except that stated in the notice.
- c. Except as otherwise provided by the Constitution and By-Laws, action on all matters brought before meetings shall be determined by a simple majority of the votes cast. No meeting shall conduct business unless there is present a quorum as defined in the By-Laws.
- d. The rules contained in Robert's Rules of Order, Revised, Seventy-fifth Anniversary Edition, shall govern this Association in all cases to which they are applicable, and in which they are not inconsistent with the Constitution, By-Laws, or the standing rules of order of this Association.

#### ARTICLE VII AMENDMENT

This Constitution may be amended by a three-fourth vote of all members present and voting at any meeting, provided the proposed amendment shall be submitted in writing, proposed and seconded at the previous regular meeting of the Association. The Secretary shall furnish copies of the proposed amendment to all members of the Association, and the proposed amendment shall be officially published, in a manner prescribed in the By-Laws, at least one week preceding the next regular meeting, at which time the vote shall be taken.

#### BY-LAWS

#### SECTION I MEMBERSHIP & DUES

- a. Dues shall be one dollar per person and shall be due annually at the May meeting and payable before the September meeting of the Association.
- b. The payment of dues shall entitle persons as described in Article III(a) of the Constitution to active membership for the fiscal year from June 1 through the following May 31, the rights of which shall include the right to vote on all questions properly brought before the membership, elegibility for elective or appointive office in the Association, and the right to participate in all Association sponsored activities.
- c. Membership shall be terminated when a member resigns or becomes more than 60 days in arrears of dues.

#### SECTION II MEETINGS

- a. The regular meetings of the Association shall be held on the first Tuesday of each month unless otherwise ordered by the Executive Committee for special and necessary reasons, and except as otherwise provided for herein.
- b. The time and place of the regular meeting shall be as set forth in the standing rules of the Association.
  - c. The Annual Meeting of the Association shall be the regular May meeting.
  - d. A quorum shall consist of 35 members of the Association.
  - e. The order of Business at meetings shall be as follows:
    - 1. Reading of the Minutes
    - 2. Reports of Committees
    - 3. Addresses and Remarks
    - 4. Unfinished Business
    - 5. New Business
    - 6. Adjournment

#### SECTION III FINANCIAL AFFAIRS

- a. The Treasurer shall collect and deposit all Association monies in a local Virginia bank that is a member of the Federal Deposit Insurance Corporation, except that a twenty-five dollar petty cash fund shall be maintained on an impressed basis.
- b. All disbursements shall first be approved by the membership at a regular or special meeting of the Association, and shall be made by check and signed by the Treasurer and countersigned by the President or the Vice President.
- c. The annual budget shall be submitted by the Treasurer for the approval of the membership at the regular September meeting of the Association. Approval of the budget authorizes disbursements in accordance therewith.
- d. The Treasurer shall maintain the records in accordance with generally accepted accounting principals and within the month preceding the Annual Meeting shall submit to the Executive Committee an account of all income and disbursements for the preceding fiscal year.

#### SECTION IV COMMITTEES AND APPOINTIVE OFFICES

- a. The President shall appoint before the close of the second regular meeting after his election the members of the following Standing Committees:
  - 1. Public Utilities
  - 2. Social and Recreation
  - 3. School
  - 4. Publicity
  - 5. Housing and Gardening
  - 6. Citizenship and Public Affairs
  - 7. Program Speakers

The members of each Standing Committee shall select their respective chairmen.

- b. The President, whenever he deems necessary, shall appoint Special Committees to further the purposes and most efficiently execute the business of the Association.
- c. The President shall appoint a Parliamentarian to assist him in maintaining the proceedings of the Association in keeping with the Constitution and By-Laws or "Robert's Rules of Order" which documents shall be inviolable.

#### SECTION V GENERAL DEFINITIONS

- a. The Regions within the Association shall be as follows:
  - Region A---Pimmit Hills Subdivision, Sections 1 and 2
  - Region B---Pimmit Hills Subdivision, Sections 4, 5, and 8
  - Region C---Pimmit Hills Subdivision, Section 3, Register's Addition; Mickler's Addition; Orchard Crest; and Leonard Subdivision, Section 1
  - Region D-Pimmit Hills Subdivision, Section 6, (Western end-from Rt. 7 to rear lot lines of homes on west side of Ware Rd.); and Leonard Subdivision, Section 2
  - Region E---Pimmit Hills Subdivision, Section 6, (Eastern end all homes from Ware Rd. through Peabody Drive, inclusive)
  - Region F---Pimmit Hills Subdivision, Section 7, and Pimmit View Subdivision, Sections 1, 2, and 3
- b. Official Publication or Official Notice shall consist of either insertion in the Association Newsletter or a Special Mailing to the members. Date of publication or notice shall be the date of release by the printer for distribution.
  - c. A poll of the membership shall consist of an absentee vote by mail.

#### SECTION VI AMENDMENT

These By-Laws may be amended by a two-thirds vote of all members present and voting at any meeting, provided the proposed amendment shall be submitted in writing, proposed and seconded at the previous regular meeting of the Association. The Secretary shall furnish copies of the proposed amendment to all members of the Association, and the proposed amendment shall be officially published at least one week preceeding the next regular meeting, at which time the vote shall be taken.
